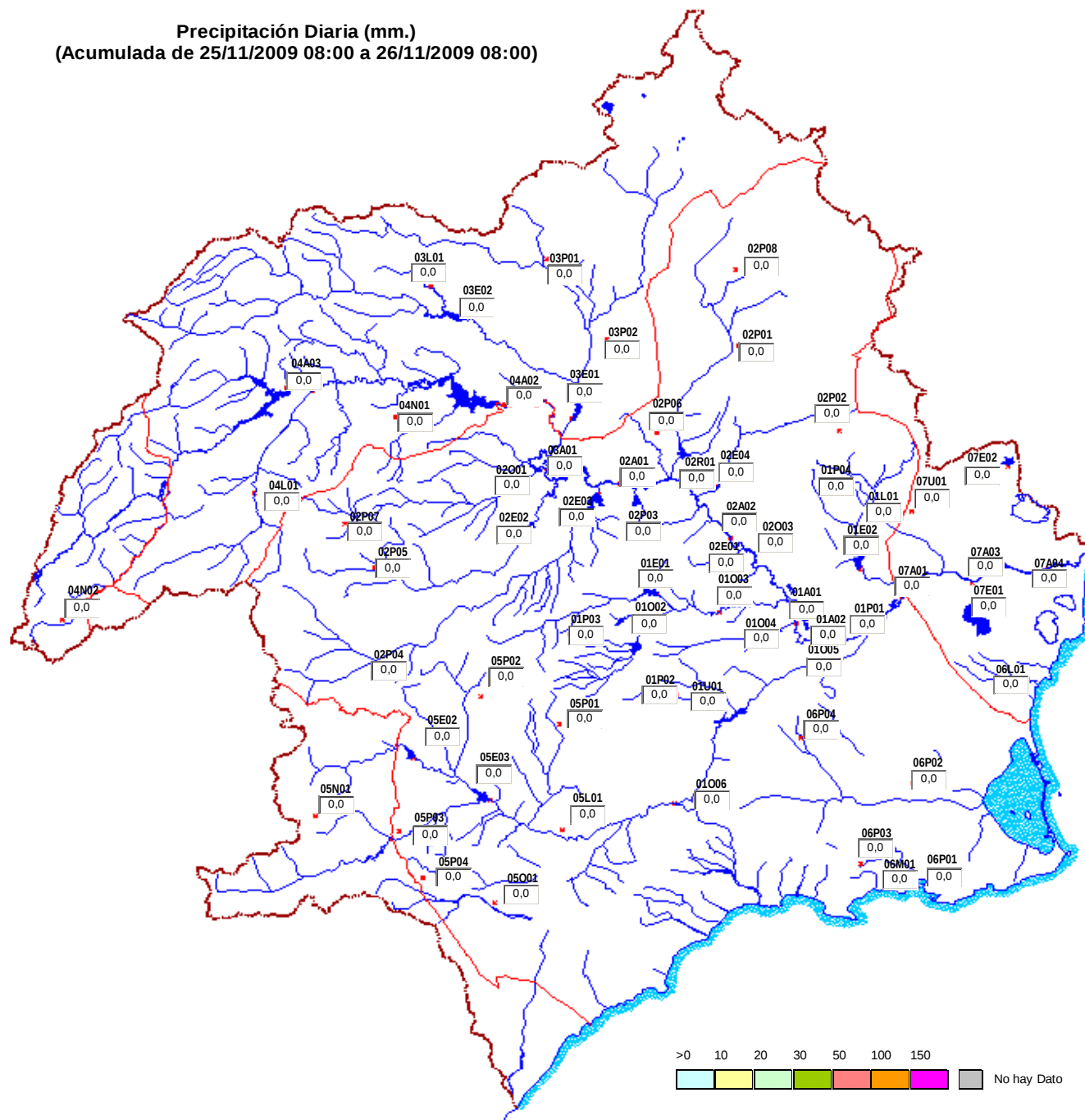
Pluviómetros Adoptados: SAIH. Método de interpolación: Kriging variograma lineal con Quadratic Drift.
