

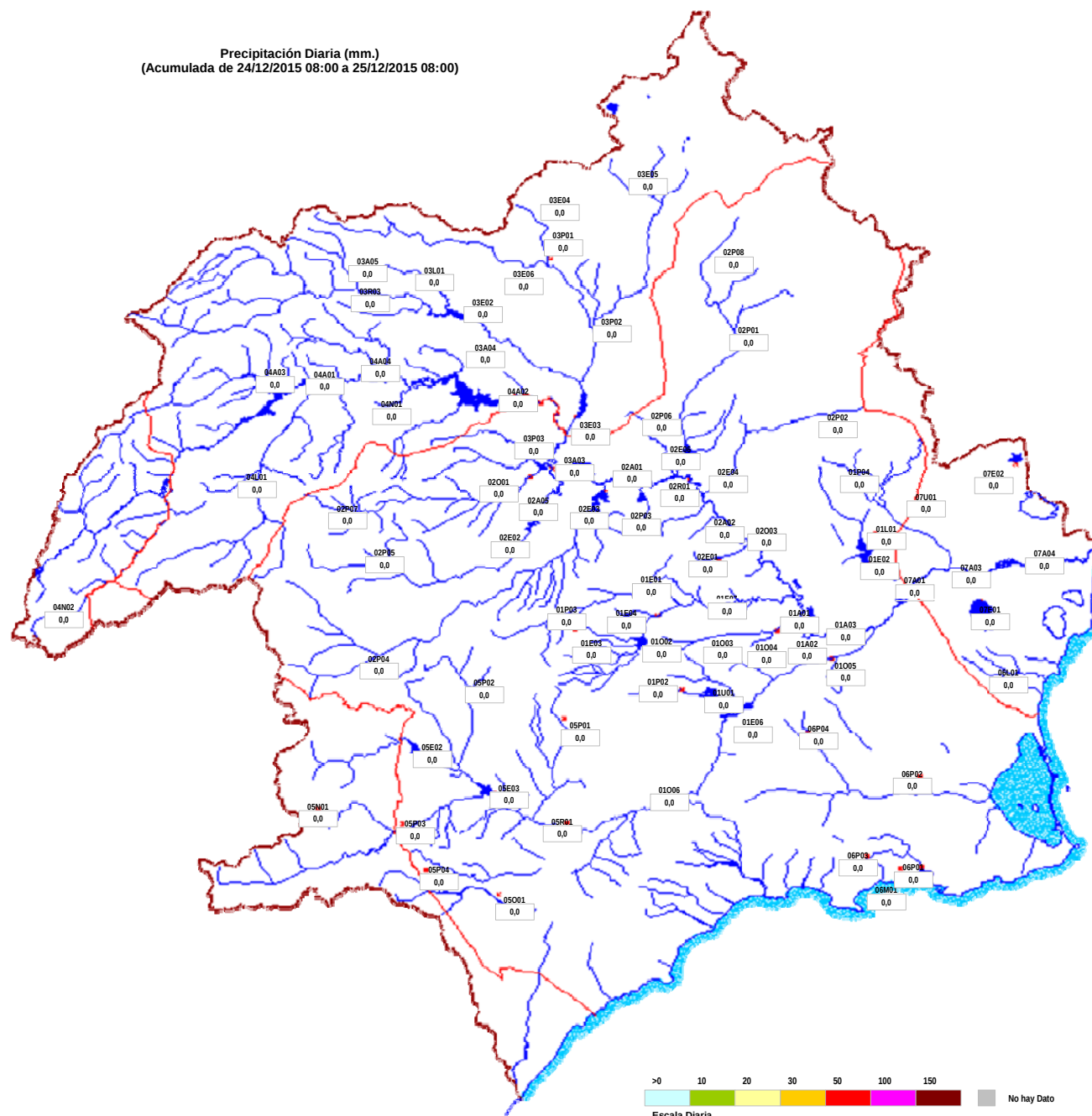
Distribución Espacial de la Precipitación Diaria (mm). (Acumulada de 24/12/2015 08:00 a 25/12/2015 08:00)
